Biography

Ryan Mauck is a litigation partner at Jeffer Mangels Butler & Mitchell LLP, which was recognized by Corporate International Magazine as the 2012 Automotive Law Firm of the Year in California. An experienced litigator, his clients have included motor vehicle manufacturers, professional sports teams and athletes, and musical artists and labels. He has successfully represented clients in numerous forums, including California trial and appellate courts, Federal district courts in four states, the Eighth and Ninth Circuit Courts of Appeals, arbitrations, administrative hearings and salary arbitration panels under Major League Baseball's collective bargaining agreement.

Among his successes:

- He has served as litigation counsel in a variety of matters for clients in the automotive industry, including civil litigation regarding contract disputes and intellectual property protection, as well as protests before the California New Motor Vehicle Board.
- He has represented several Major League baseball teams in connection with salary arbitrations, including the Los Angeles Dodgers' successful arbitrations against Cy Young winner Eric Gagne and Joe Beimel and the Los Angeles Angels of Anaheim's arbitrations against closer Francisco Rodriguez and catcher Jeff Mathis.

The case was resolved as part of a \$1.35 billion dollar acquisition of the Michelson patent portfolio, which the Los Angeles Times reported as the largest acquisition of patents in history.
